NJDEP sent notice that they are seeking comments on a preliminary Draft Renewal of the Tier A MS4 NJPDES permit.

The Delaware Estuary Foundation sent notice of their intent to rewrite the Comprehensive Conservation and Management Plan for the Delaware Estuary. They have requested that previous partners confirm their interest in the process to remain informed on the process and have the opportunity to participate in the development of the plan.

Mr. McGee advised the board that he continues to consider options to replace the District's Dodge Caravan.
